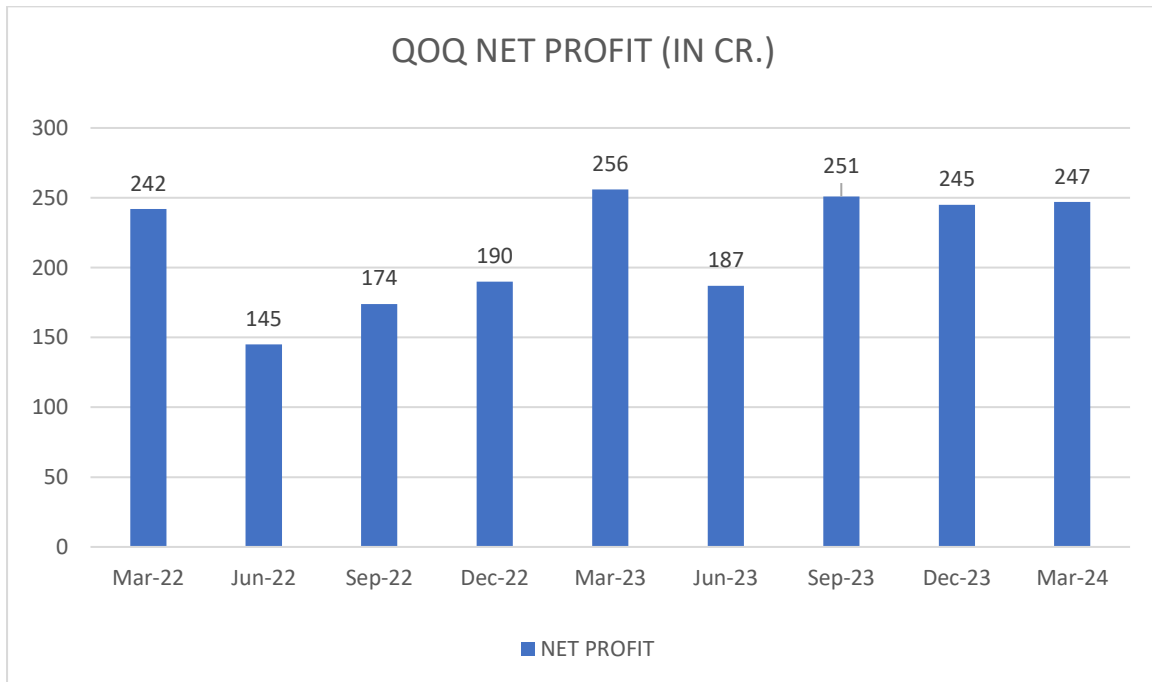
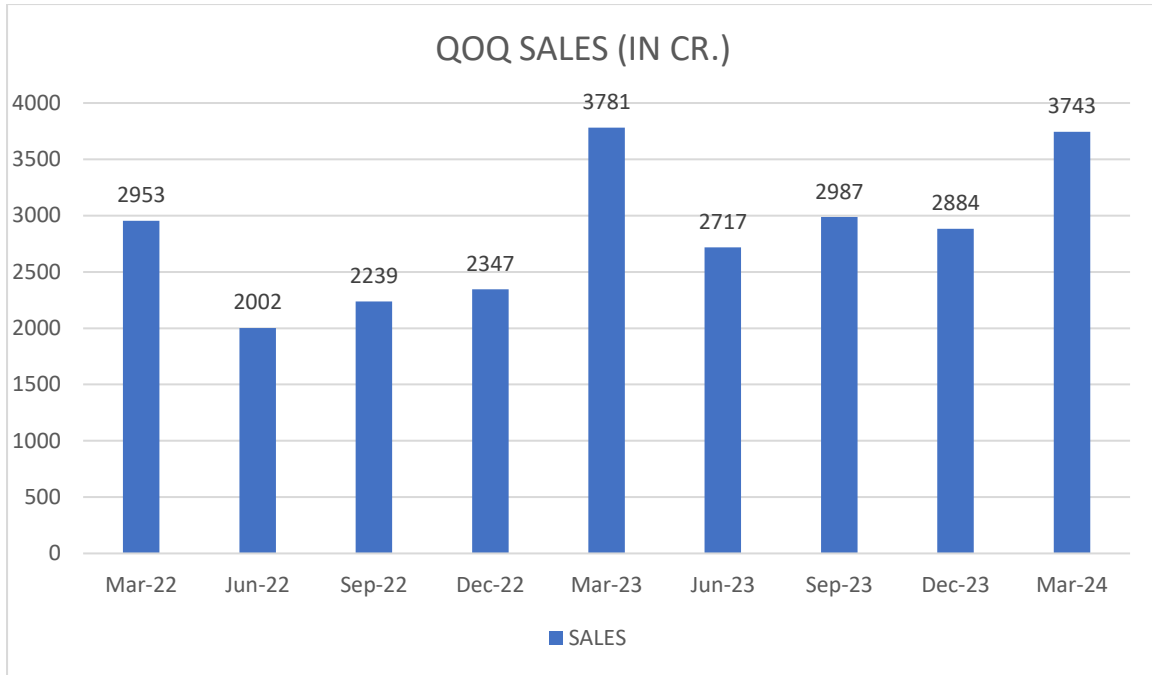
About Company

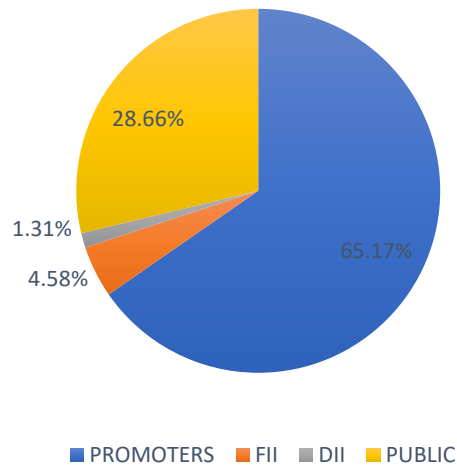
