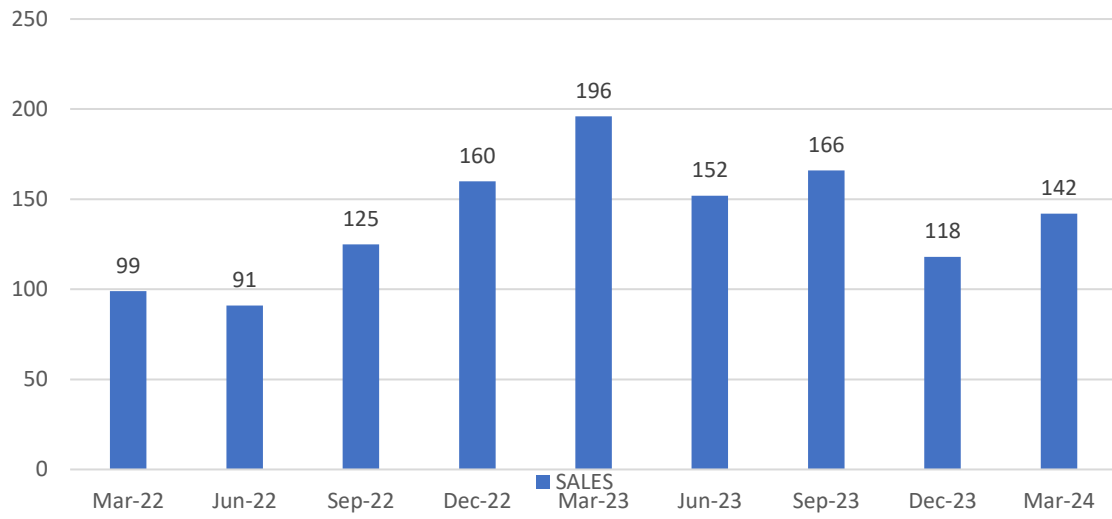

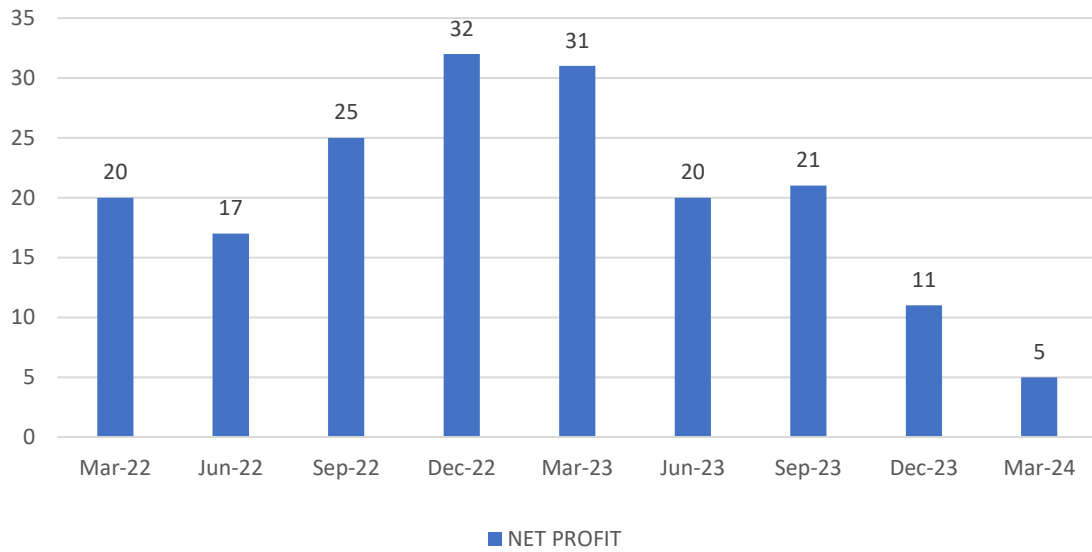

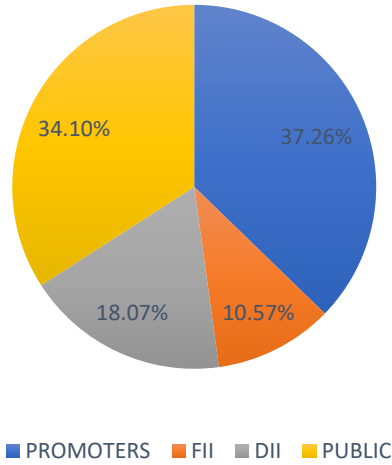
QOQ SALES (IN CR.)
