About Company

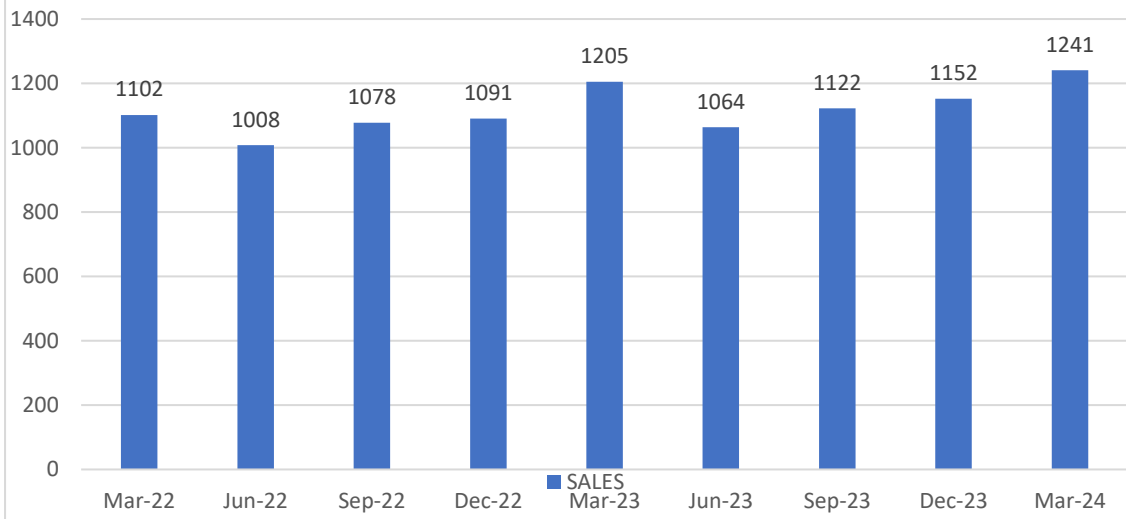

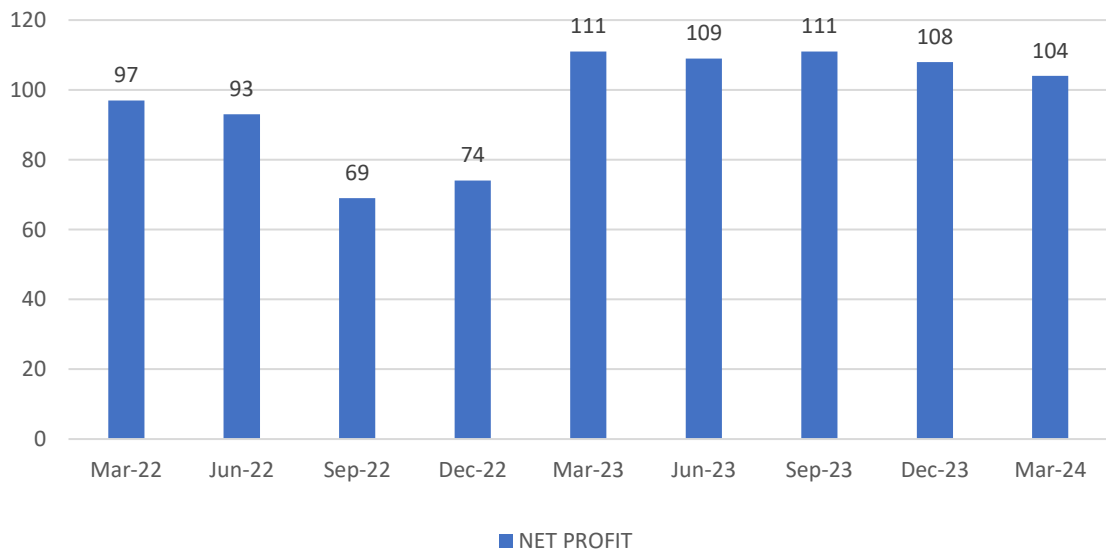

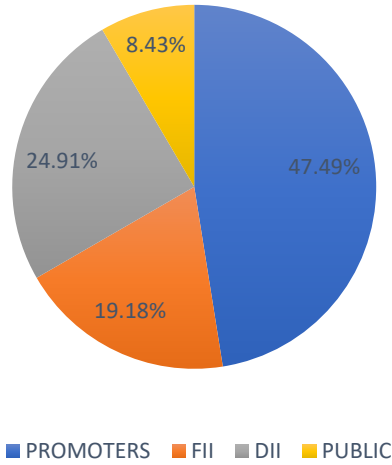
QOQ SALES (IN CR.)

In the last 5 years Net Profit has jumped significantly from Rs.229 cr. to Rs.432 cr. On the basis of above information we gave Buy signal in the stock, also the breakout shows a momentum in short term. Hence buy recommendation was given in the stock.
