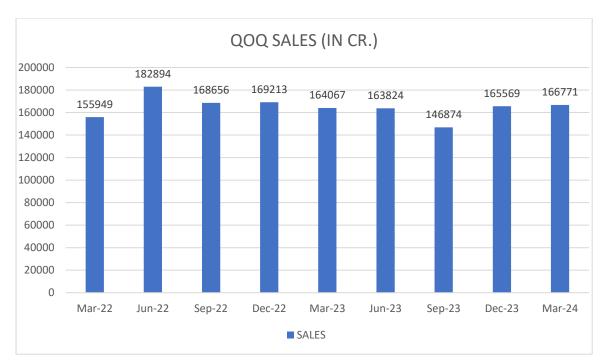

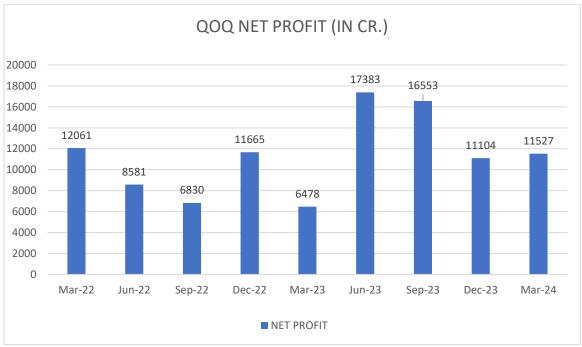

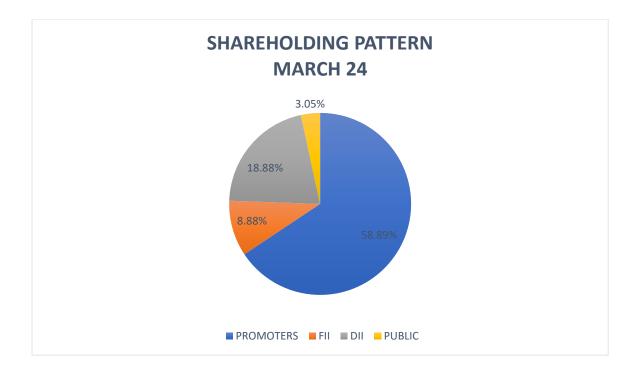

The stock appears to have strong resistance around the 300 level, which it has struggled to break through consistently and is trending above supertrend and 34 moving average indicator. The rising volume in 30 min chart and bullish candles shows an upward trend. Also other PSU's stocks like Coal India, OIL were also rising. If we look at the fundamentals of the company sales is rising on quarterly basis from Rs 165,569 cr. in Dec 23 to Rs 166,771 cr. in March 24 and Net Profit has increased on

quarterly basis from Rs 11104 cr. in Dec 23 to Rs 11527 cr. in March 24. Promoter holding is 58.89%. On the basis of above information, we gave Buy signal in ONGC 300 Call.
