
About Company





TECHNICAL ANALYSIS

The stock has been on an upward trajectory since late March, as evidenced by the higher highs and higher lows. The 21-day EMA (Exponential Moving Average) and the 55-day EMA are both trending upwards and are positioned above the 200-day EMA, suggesting strong

bullish momentum. The SuperTrend indicator also supports the upward trend. Recent price action shows the stock breaking above a key resistance level around 590 indicating the bullish momentum. On the basis of this information, we gave a buy signal in Jubilant Foodworks 595 Call Option.
