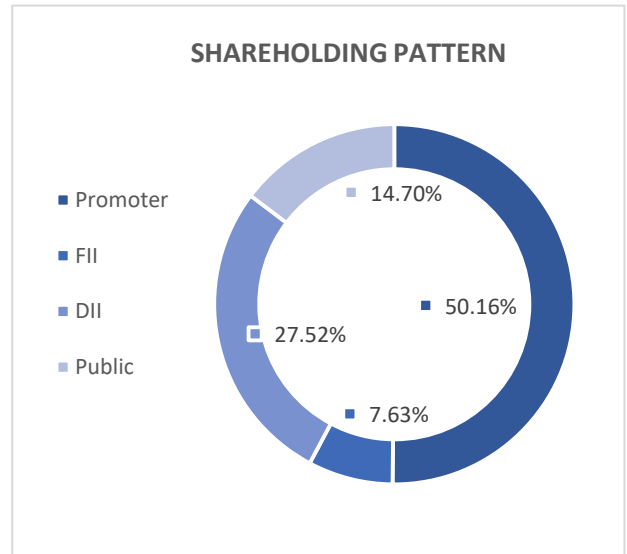
About company

Technical analysis

The Supertrend indicator has shifted to a buy signal around ₹1,417, indicating the reversal of the earlier downtrend. The price recently broke above the 20-period EMA, suggesting bullish momentum as it reclaimed the ₹1,421 level. The recovery from the ₹1,400 support level signals renewed buying interest, with resistance visible near ₹1,436. Hence we recommended to buy Bata India 1440 call option.
