Technical analysis

The L&T Finance Ltd 15-minute chart indicates a volatile trend with a recent pullback from the 187.50 level. After a dip to around 177, the stock rebounded sharply, crossing above the 20-period EMA, indicating buying interest. The supertrend indicator turned green, signaling bullish momentum. Hence we recommended to buy LTF 190 call option.
