






## <u>About company</u>





## **Technical analysis**

The chart of Bata India Ltd. reflects positive momentum emerging after a consolidation phase. The stock has recently broken out of a sideways pattern and moved above the 20-period Exponential Moving Average (EMA), indicating a shift. The upward spike towards the end of the chart, accompanied by increasing volume, suggests strong buying interest. The Supertrend indicator is close to flipping to a bullish signal, suggesting the potential for further upside. So on the basis of above analysis we recommended to buy Bata India 1460 call option.
