Technical analysis

The Nifty 50 Index chart shows a significant downtrend. Currently, the price is trading around 25,254, which is below the 20-period EMA of 25,398, indicating a bearish trend. The Supertrend indicator has issued a sell signal at approximately 25,391, reinforcing the downward momentum. Key support is observed at 25,250, where the price is currently consolidating, while immediate resistance is noted near the 25,398 level. Hence we recommended to buy NIFTY 25250 put option.
