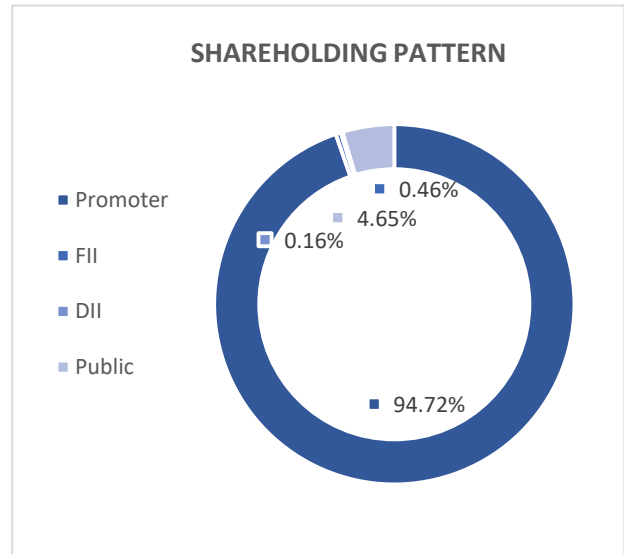
## About company

IDBI bank was trading in downtrend with super trend indicator giving sell signal but now the indicator has given a buy signal has the stock is trading above the supertrend line. The stock is trading above the EMA 20 line indicating a further momentum in the stock. 3 years CAGR of profit growth is 56% and the YOY sales has jumped from 20592 to 26446 in FY 24. Hence we recommended to buy IDBI bank.
