Technical analysis

The Asian Paints Ltd. 15-minute chart reflects a promising recovery after a recent downtrend. The stock has found strong support around the ₹3,065 level, with the Supertrend indicator turning green, signaling a potential shift towards bullish momentum. While the price is still slightly below the 20-period EMA, increasing buying volume and the price's upward movement suggest that a breakout above ₹3,120 could confirm a more sustained uptrend. Hence we recommended to buy Asian Paints 3140 call option.
