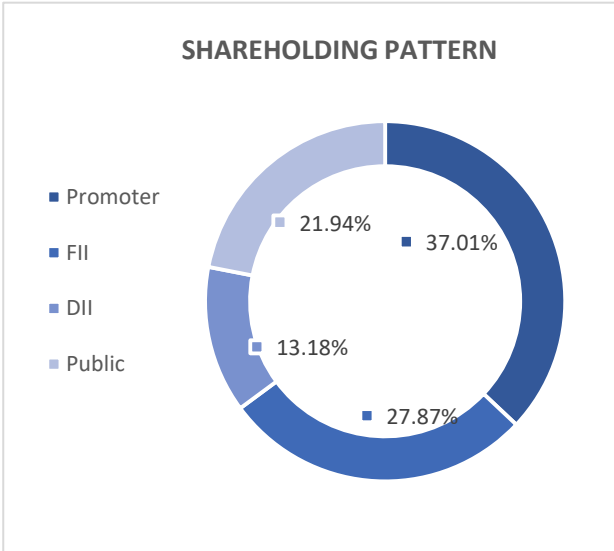
## About company

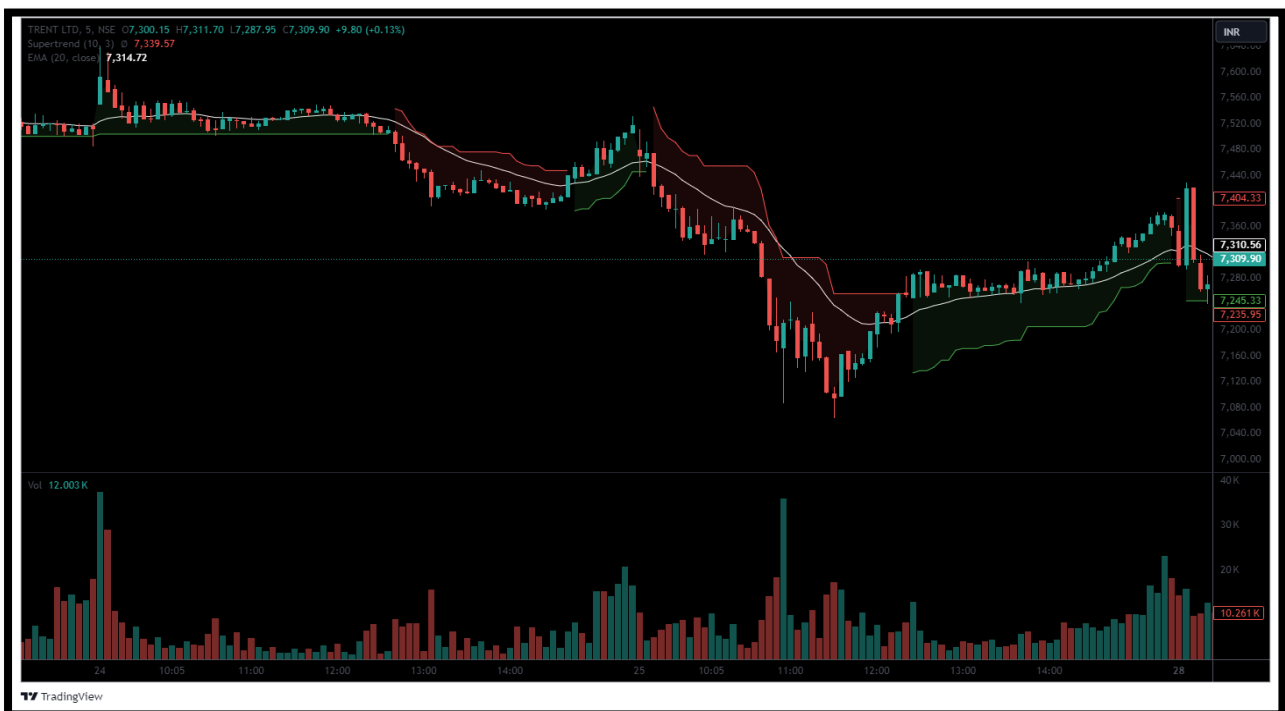

**Technical analysis**

Trent stock prices opened flat, but volumes are increasing. The share prices are unable to sustain above 7400 level and fell down quickly. The prices, then, went below its 20 EMA level, indicating some pressure on it. Thus we recommended buying TRENT 7200 Put Option.
