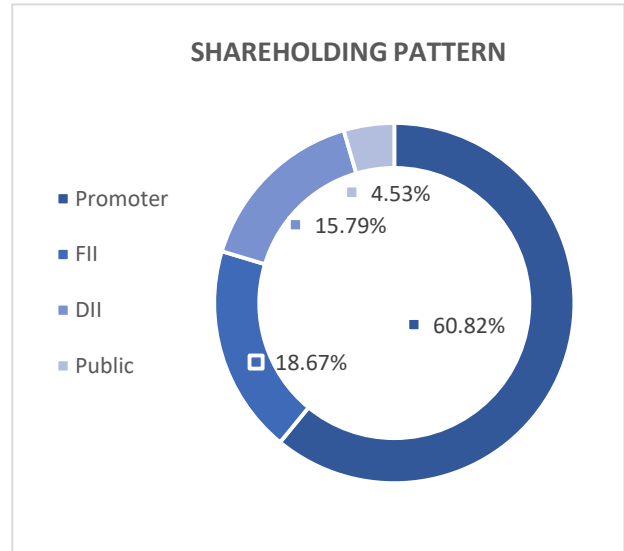
## About company

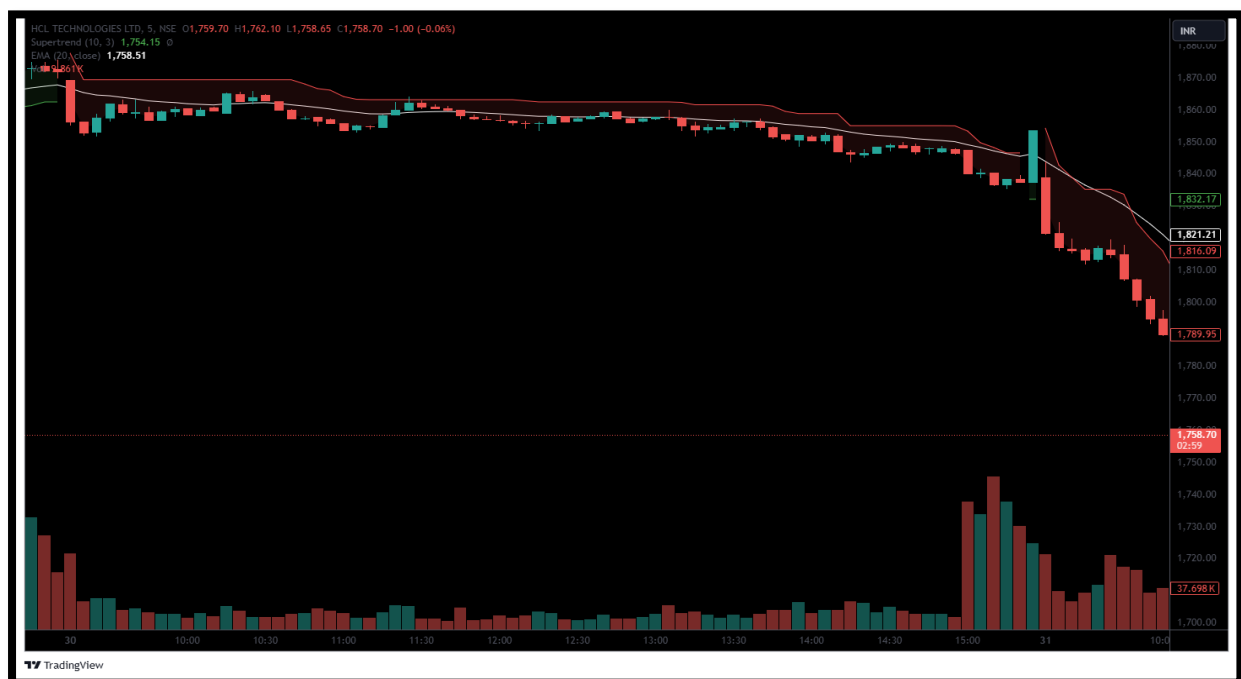
