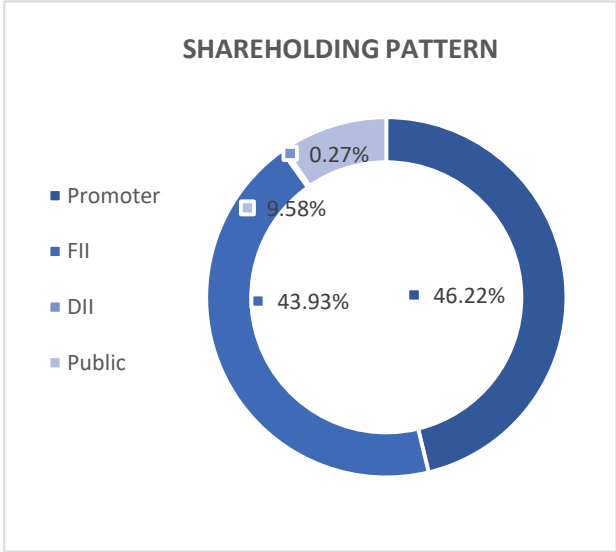
## About company
