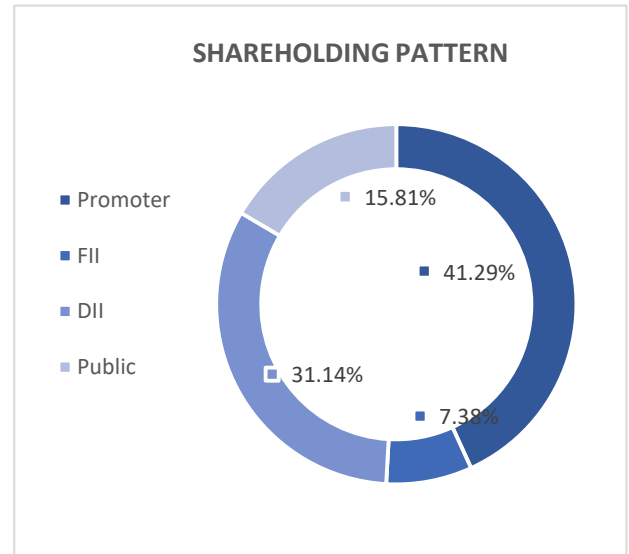
About company
