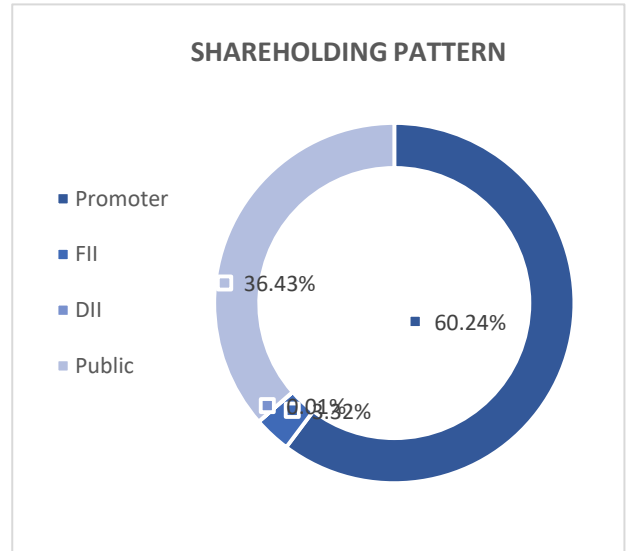
## About company

### Technical analysis

The 1-hour chart for Kabra Extrusiontechnik Ltd shows a strong bullish trend, with the stock rising from around ₹410 to ₹472, backed by higher trading volumes. The price is comfortably above the EMA indicating positive momentum. The Supertrend provides solid support at ₹451.78, and the recent breakout above ₹471.75 suggests potential for further upward movement. If we talk about fundamentals the company's 3 years CAGR of sales and profit stands at 30% and 9% respectively. Hence we recommended to buy Kabra Extrusion.
