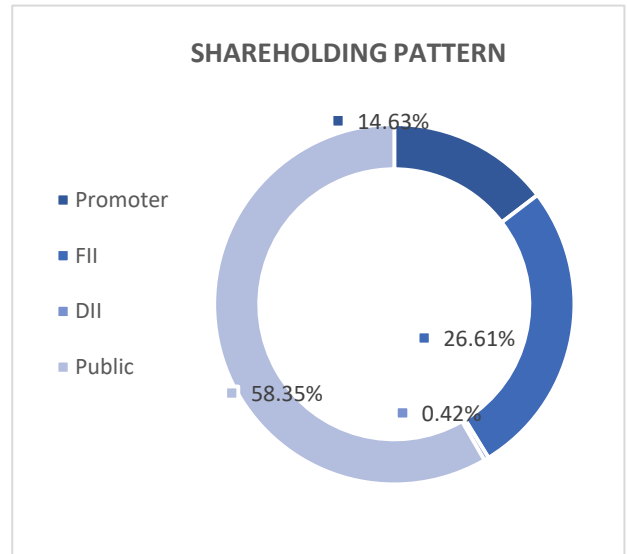
About company
