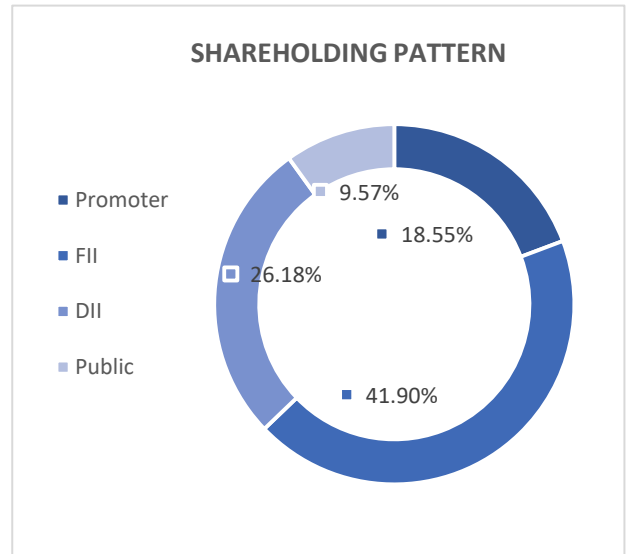
About company
