Technical analysis

The Gland Pharma Ltd. chart shows a recent upward trend with the price consistently staying above the EMA 9 line, indicating bullish momentum. The Supertrend indicator also signals a buy, as it has been under the price for most of the observed period. Currently trading at 1,804.60, the stock appears to have strong support around 1,750 and resistance near 1,825, suggesting potential for continued growth if it breaks above the resistance level. Hence we recommended to buy Gland pharma.
