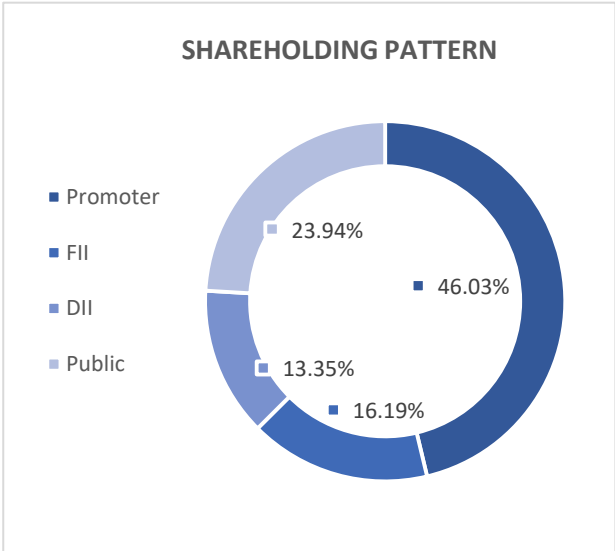
## About company

### Technical analysis

The stock is trading above its EMA 20 level. The Supertrend indicator further supports this bullish sentiment, with the price staying above the green band. The upward movement after breaking previous resistance level around 1215 suggests strength and the possibility of further gains. So we recommended buying PEL 1220 call option.
