






### **About company**





The prices breaks previous resistance level of 1530 and sustain above it, indicating further upside move. On technical front, Both 20 EMA & Supertrend are indicating bullish trend. Hence we recommended to Buy CIPLA 1540 Call Option in expectation to reach at least previous resistance area of 1550.
