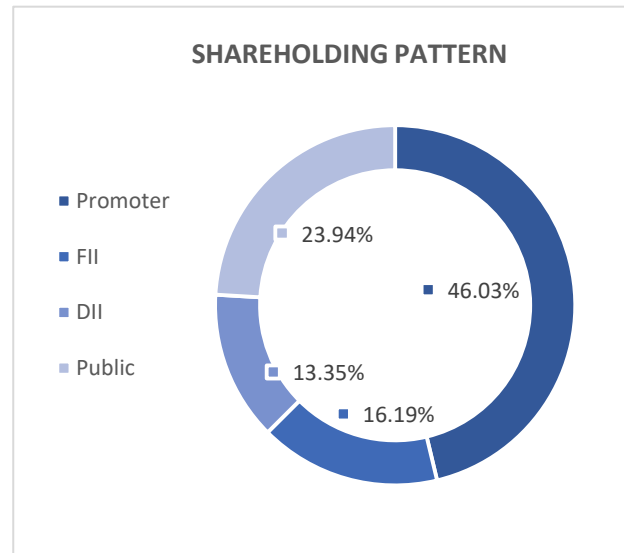
About company

Technical analysis

The chart of Piramal Enterprises Ltd. (PEL) on the 5-minute timeframe shows a positive shift in momentum. The share continues its bullish trend and making higher high formation. The stock is trading above its EMA 20 level. The Supertrend indicator further supports this bullish sentiment, with the price staying above the green band. The upward movement after breaking previous resistance level around 1230 suggests strength and the possibility of further gains. So we recommended buying PEL 1240 call option.
