

Technical analysis

This chart of Credo Brands Marketing Ltd. (1-hour timeframe) shows a strong upward momentum as prices have moved above the EMA (Exponential Moving Average) of 187.13 and the Supertrend support at 181.27. The breakout from the recent consolidation zone, accompanied by increased volume, indicates bullish strength. If we talk about fundamentals the 3 years CAGR growth of sales and profit stands at 25% and 84% respectively. So on the basis of above analysis we recommended to buy Mufti.
