Technical analysis

TK Prestige is exhibiting a positive trend, with a strong recovery after a period of consolidation and a breakout above key resistance levels. The stock is forming higher highs and higher lows, reflecting sustained upward momentum supported by an increasing ATR trail. Looking at the fundamentals the quarterly sales has jumped to 750 Cr and profit also increased to 52Cr. Thus we recommended to buy TTK PRESTIGE.
