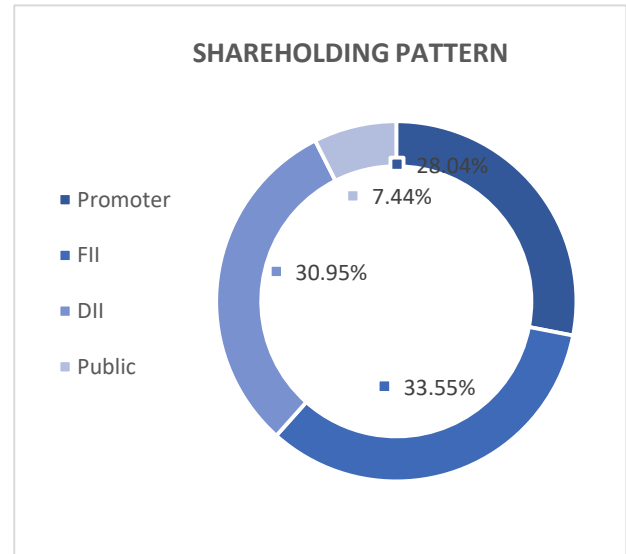

This chart represents the 1-hour time frame of Sona BLW Precision Forgings Limited, showing a consolidation phase with positive signals. The price is hovering around the 20-period EMA, indicating potential accumulation and readiness for an upward breakout. The Supertrend indicator is also nearing a bullish flip. If we look at the fundamentals the year CAGR growth of sales and profit stands at 27% and 32% respectively. Thus, we recommended to buy Sonacom.
