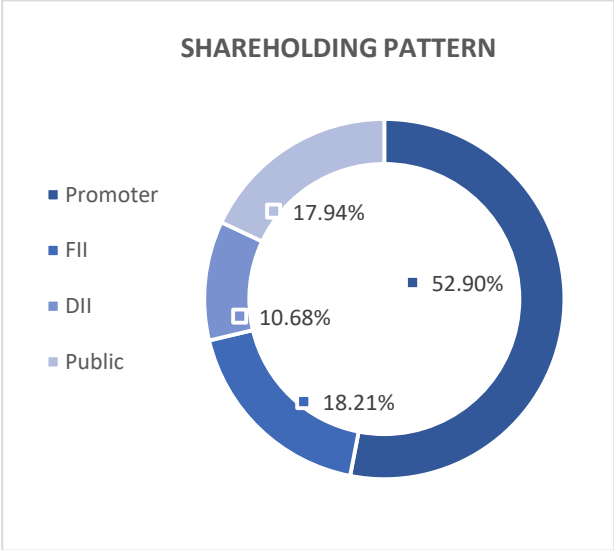
## About company

**Technical analysis**

Titan Company share prices continue its bullish move which has started since yesterday after breaking strong resistance of 3400 level. The prices opened flat today but quickly recovers and breaks previous resistance of 3470 level. The prices are trading above 3470 level with good volumes, indicating a potential of an upside move. On technical front, the prices are trading above its 20 EMA level indicating a bullish momentum. Supertrend indicator is showing bullish trend as green zone is active in it (as shown in image below). Thus, we recommend TITAN 3450 CALL options.
