Technical analysis

Hindalco Industries Ltd share prices moved higher since the opening of the today's session as metal index is getting strong upside momentum. The price breks previous resistance of 676 with good volumesh. On technical front, the prices are trading above its 20 EMA level, indicating a bullish momentum. Supertrend indicator is showing bullish trend as green zone is active in it (as shown in image below). The prices are likely to reach 685 level and for the downside 668 can act as a support level. On the basis of above analysis , we recommend HINDALCO 680 CALL options.
