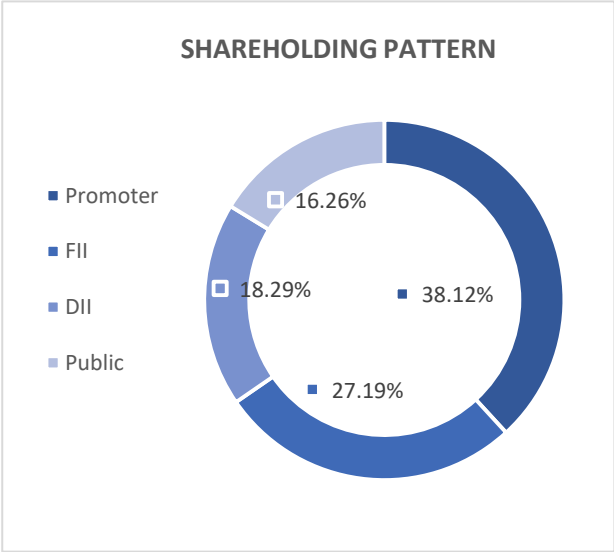
About company

Technical analysis

The volumes are also dried up in this fall, which indicate weak bearish move. The overall trend is bullish in this stock as it continuously making higher high formation on daily chart, thus we are looking for the buy opportunity in this stock. For bullish confirmation, we waited price to come above its 20 EMA level and Supertrend indicator to suggest bullish zone. Once these confirmations filled then we go with the probability of upside move. On the basis of above analysis, we recommend INDHOTEL 900 CALL option.
