Technical analysis

Oil and Natural Gas Corporation share prices opened higher with positive bias. The prices continue its bullish momentum after coming out from yesterday's consolidation phase. On technical front, the prices are trading above its 20 EMA level of 265.4, indicating a bullish momentum. Supertrend indicator is showing bullish trend as green zone is active in it (as shown in image below). The stock is making higher high formation thus it is likely to continue its bullish momentum. On the downside, 262 can act as a support level. On the basis of above analysis, we recommend ONGC 270 CALL option.
