






About company





Technical analysis

The Indian Hotels Co Ltd share prices opened flat but remained under pressure since the beginning of today's session. The trend turns bearish after it breaks its minor support level at 850. Since then the prices remained under pressure with no sign of bouncing back. The prices are continuously trading below its 20 EMA level, indicating a potential of a further downside move. The price breaks the next support level of 840, forming lower lows formation, indicating a possibility of further downside move. The bearish view is backed by couple of indicators, such as the prices are trading below its 20 EMA level and Supertrend indicator is showing bearish trend as red zone is active in it (as shown in image below). Thus, we recommend INDHOTEL 820 PUT option.
