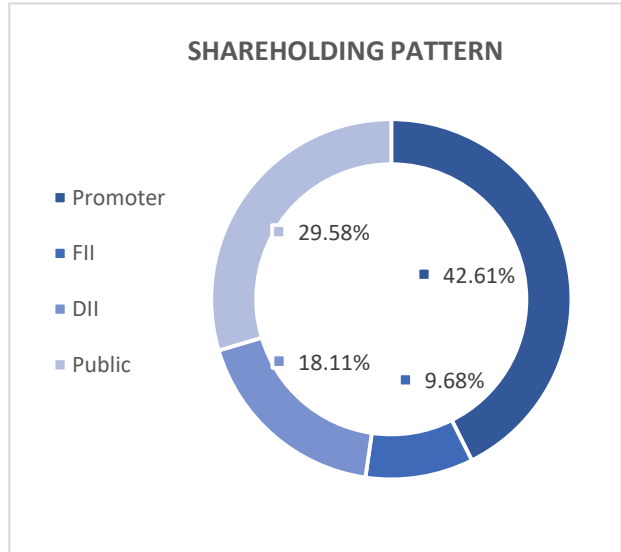
## About company

**Technical analysis**

Aarti Industries Ltd share prices opened higher with positive bias. The price is taking support near 400 level after falling from morning highs. The trend turned bullish yesterday after it breaks 395 level. However, volumes arise today in the stock, indicating good potential for an upside move. On technical front, the prices are moving above its 20 EMA level of 402.10, indicating a potential bullish momentum. Supertrend indicator is showing bullish trend as green zone is active in it (as shown in image below). The stock is making higher high formation thus it is likely to continue its bullish momentum. On the downside, 395 can act as a support level. On the basis of above analysis, we recommend Aarti Industries 410 CALL option.
