The price is trading below its 20 EMA level 1675, indicating a potential of a further downside move. Supertrend indicator is showing bearish trend as red zone is active in it (as shown in image below). The prices are expected to continue its bearish run for more 1-1.5% and on the upside 1680 can acts as the resistance level. Thus, we recommend HDFCBANK 1670 PUT option.
