Technical analysis

Indian Energy Exc Ltd share prices opened gap down and sustained at lower levels. The stock remained under pressure since the beginning of today's session. The price is trading below its 20 EMA level 164, indicating a potential of a further downside move. Supertrend indicator is showing bearish trend as red zone is active in it (as shown in image below). The prices are expected to continue its bearish run for more 1-1.5% and on the upside 166 can acts as the resistance level. Thus, we recommend IEX 165 PUT option.
