Technical analysis

Dixon Techno (India) Ltd share prices opened flat with negative bias. The stock moved lower after finding resistance near yesterday' high level but the volumes did not rise in this fall which indicates a weak selling. Soon, prices recovered and broke the previous days high with good volume. On technical front, the prices are trading above its 20 EMA level of 16764, indicating a bullish momentum. Supertrend indicator is showing bullish trend as green zone is active in it (as shown in image below). The stock continuously trading higher without any strong pullback, thus it is likely to continue its bullish momentum. On the downside, 16700 can act as a support level. On the basis of above analysis, we recommend DIXON 17500 CALL option.
