






About company





Technical analysis

Jindal Steel Ltd share prices flipped into bearish trend today after remaining in a consolidation phase for brief period of time. On technical front, the prices are trading below its 20 EMA level indicating a bearish momentum. Supertrend indicator is showing bearish trend as red zone is active in it (as shown in image below). The prices are expected to fall 1-1.5% more from current level as the sentimens are negative at the moment. On the higher side 790 can act as the resistance level. Thus on the basis of above analysis, we recommend JINDALSTEL 740 PUT option.
