Technical analysis

IndusInd Bank Ltd share prices flipped into bearish trend today after remaining in a consolidation phase for brief period of time. The volume also increasing with this pullback, indicating possibility of further downside momentum. On technical front, the prices are trading below its 20 EMA level indicating a bearish momentum. Supertrend indicator is showing bearish trend as red zone is active in it (as shown in image below). It breaks previous support of 1045 and sustaining below it. The prices are expected to fall 1-1.5% more from current level as the sentiments are negative at the moment. On the higher side 1050 can act as the resistance level. Thus on the basis of above analysis, we recommend INDUSINDBK 1030 PUT option.
