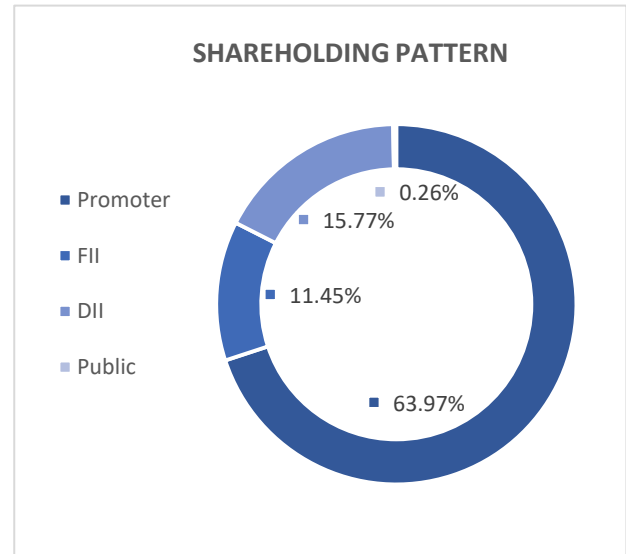
About company

The prices continuously making lower low formation with good volumes, indicating strength in its bearish run. On technical front, the price of Index is trading below its 20 EMA level indicating a bearish momentum. Supertrend indicator is showing bearish trend as red zone is active in it (as shown in image below). The prices are expected to reach 203-204 levels. On the higher side 210 can act as the resistance level. Thus on the basis of above analysis, we recommend BANKBARODA 205 PUT option.
