






# **About company**





# **Technical analysis**

Aarti Industries Ltd share prices opened flat with negative bias. The stock remain in bullish trend for brief period of time, but it starts falling after taking resistance near 450 level. Today, it continue its bearish trend and breaks previous support of 424. On technical front, the prices are trading below its 20 EMA level indicating a bearish momentum. Supertrend indicator is showing bearish trend as red zone is active in it (as shown in image below). With the current momentum the stock prices are expect to move 1.5-2% more on the downside. On the upside, 443 can act as the resistance level. Thus on the basis of above analysis, we recommend AARTIIND 420 PUT options.
